DISCOUNTS

Must qualify at registration, cannot claim retroactively. Use the online discount wizard to calculate your payment rate, then manually edit your amount before paying.

Annual Discount: 10% off when *one in-full* payment is received by the deadline.

Sibling Discount: 5% off when enrolling two or more children. Only applies to the 2nd or more child with tuition of *equal or lesser value*.

Corporate Discount: 5% off if Corporate I.D. (with parent & company name) is received **annually w/ registration form**. Qualifying corporations are listed on the Registration Form.

Quarterly and Bi-Annual discounts are distributed with each payment throughout the year.

Discounts are not honored in the withdrawal policy.
